Directions from I-94 and M-40 (Paw Paw exit 60): drive north on M-40 until it meets M-43 (approx. 6 miles north of Paw Paw). Turn right onto M-43 and drive 4.4 miles to 25<sup>th</sup> street. Drive ½ mile to the 3<sup>rd</sup> driveway on the right and turn right into the driveway Drive an additional ½ mile to the house (32180 25<sup>th</sup> Street).
