Called to Order: 9:03 AM

Cheryl presented Treasurer's Report Rebecca moved to accept, Mike 2nd, motion carried. Savings \$12,014 in checking account. Down \$290 from last year.

Monument Committee Update- Bob send report. We took in \$1000 after the ceremony in September, and took in another \$1000 from Nick Walton's memorial. 4 already to go on the monument, but usually wait until we have 10 to have a ceremony. Tentatively scheduled ceremony for September 2024. We need to have some work done on the concrete in 2023, but nothing major and will be handled by Bob and Mike Bradford.

Website- Doug said voting went well, and the membership program is up and running well. We can use that in the future for Newsletter and points to make it quicker. Send updates to Doug for the website and he will post ASAP. We also want to test out online registration at Spikes for this year, and maybe more races if it goes well.

Cheryl recommends split cost of registration program to Skye High Gymnastics for running our race registrations- we are tabling this until the meeting later this year when we have more information on the costs.

Insurance- Insurance covers all of the races, so we need to communicate this to the race directors. Last year some races used other insurance because they may not have been aware of the program. Kyle will reach out to each race to confirm their needs.

Kyle, Lynne, and Zach will work to put the liability clause in the bylaws for insurance purposes and we will complete a vote once the following verbiage is inserted in the proper article

"Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Any assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located. Disposal shall be made exclusively for exempt or public purposes, or be made to such organization or organizations as the court shall determine to be organized exclusively for such purposes."
